EDUCATION: KAKENYA'S DREAM ADVANCES EDUCATIONAL ACCESS AND QUALITY FOR MARGINALIZED GIRLS IN RURAL SOUTHWESTERN KENYA THROUGH A MULTI-PRONGED APPROACH WITH ITS LOCAL PARTNER. IN 2025, THE ORGANIZATION SUPPORTED 440 GIRLS ENROLLED IN THE KAKENYA CENTERS FOR EXCELLENCE, TWO FULL-SUPPORT SCHOOLS PROVIDING HIGH-QUALITY INSTRUCTION, LIFE-SKILLS TRAINING, AND EXTRACURRICULARS WHILE PROTECTING GIRLS FROM FGM AND CHILD MARRIAGE. THROUGH THE EDUCATION ACCESS PROGRAM, 224 ADDITIONAL GIRLS RECEIVED SCHOLARSHIPS TO LOCAL SCHOOLS, ENABLING THEIR TRANSITION TO HIGH SCHOOL. ADDITIONALLY, WE ASSESSED 20 LOCAL SCHOOLS FOR TARGETED INTERVENTIONS TO ENHANCE LEARNING QUALITY ACROSS THE REGION. WE ARE COMMITTED TO ENSURING EVERY GIRL HAS ACCESS TO A SAFE, QUALITY EDUCATION.

IN COLLABORATION WITH OUR KENYAN PARTNER, KAKENYA'S DREAM FUNDS JIJUE ("KNOW YOURSELF"), A STRUCTURED ADOLESCENT SEXUAL AND REPRODUCTIVE HEALTH AND LEADERSHIP TRAINING PROGRAM. THE CLINIC HAD OVER 12,000 VISITS IN 2025.
